

UPGRADE GLOBAL DECISION MAKING WITHOUT REVISING THE UN CHARTER

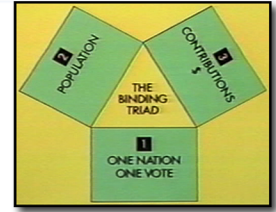
WEIGHTED VOTING



Just by a resolution of the General Assembly, the governments could say: We agree that the UN General Assembly can pass **binding and enforceable legislation**, with sufficient mechanisms of implementation and financing to achieve the goal set.

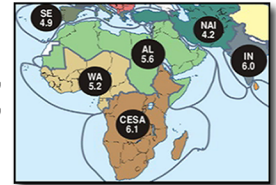
THE BINDING TRIAD

The idea of the **Binding Triad** is that in the General Assembly, to become **world law**, votes for resolutions would count in three ways. First, 2/3 of the member states must concur. Secondly, 60% of the world population is on board. Thirdly, countries approve who contribute an agreed majority of the UN budget.



UNIVERSAL REGIONAL REPRESENTATION

In the Security Council, every country in the world would belong to some region, represented in clusters. Each nation has an assigned weight, based on its population, its assessment for UN financing, and its status as a state.

THE PROGRESS OF DEMOCRACY



When you look at 1900, there were zero democracies with universal suffrage. Today, 60% of the world's population in 118 countries lives in electoral democracies. The reasoning of democracy is that those governed by an executive should have a say in selecting that executive and holding it accountable. But, in the process of globalization, only the government executive is represented, and nobody else.



A UN CHARTER REVIEW CONFERENCE THROUGH ARTICLE 109

Article 109 is truly a peaceful revolution. This **UN Charter Review Conference** itself could legally adopt the resolution to initiate the transformation of the UN into a global federation of nations. A bicameral world parliament envisions in one house the nation states and in the other chamber, the elected representatives of the people of the world. The principles of rights and political organization have existed for a long time. All that remains is to transport them to the global level.

The final step on the way we govern ourselves is a world government. We have the main body, which is the **Congress of the Earth**, consisting of 1000 women and 1000 men, one from each world congressional district of 6.5 million people. The **Auditor General** will be elected directly by and be answerable only to the people. The Auditor General will have three primary functions: over the elections, as an ombudsman, and to monitor the United Nations for waste and corruption.
